## Submitting the application

The application is to be submitted to the county (or Budapest) police headquarters issuing the licence, or, in the case of a certificate of registering an activity, the police headquarters issuing the certificate.

## Costs and expenses of procedure:

#### A) Replacing a licence:

An administrative service fee of HUF 7,000 (seven thousand).

The fee is to be paid into the appropriation allocation fund account of the county (or Budapest) police headquarters in charge of the case, in advance or retrospectively.

- 1. Account numbers: see Decree of the Ministry of Interior 53/2012. (X. 26.)
- 2. Advance payment (recommended): "pirotechnikai engedély pótlása" ("Replacing a licence for pyrotechnic activities) to be indicated in the reference field.
- 3. Retrospective payment: to be made at the latest within one day after knowledge of the registration number of the authority in charge of the case (Registration number: the "RZSEIR" registration number indicated on the notification sent by the document management system of the Police to the applicant's Client Gateway storage space).

## B) Replacing a certificate:

General procedure fee of HUF 3,000 (three thousand)

The fee is to be transferred to the account of the county (municipal) police headquarters in charge of the case, in advance or retrospectively.

- 1. Account numbers: listed at the end of the Customer Information
- 2. Advance payment (recommended): "pirotechnikai igazolás pótlása" ("Replacing a certificate for pyrotechnic activities) to be indicated in the reference field of the transfer
- 3. Retrospective payment: to be made at the latest within one day after knowledge of the registration number of the authority in charge of the case. The registration number of the case is to be indicated in the reference field of the transfer. (Registration number: the "RZSEIR" registration number indicated on the notification sent by the document management system of the Police to the applicant's Client Gateway storage space).

## Attachments to be added to the application:

1. In the case of an advance payment of the administrative service fee to the Police, a proof of the payment.

## Processing the application

If during the processing of the application it is established that an eligible customer has submitted a fully completed application to the relevant authority or has complied with the request for supplying missing items, the authority in charge shall take measures to replace the damaged or lost licence/certificate.
