### **Procedural order**

### Submitting an application

In the case of a repairer, the notification shall be submitted to the Police station whose jurisdiction covers the location where the activity is carried out; in the case of manufacturers and distributors, it will be the Police Headquarters responsible for the activity. If in Budapest, this will be the Metropolitan Police Headquarters.

#### Costs and expenses of the procedure

The procedure of administrative service is free of charge.

#### PDF extension files attached to the application

 a statement of the law on the quantity of firearms, ammunition, ammunition items in storage, the manner in which the compulsory and legally validated records are closed, and its completion

At the request of the authority the applicant must present the original of the attached documents.

On suspending the activity, on terminatating the authenticated registers, the authenticated registers and the issued firearm dealer licence (s) – card document – shall be revoked by the licensing authority. On resuming the activity after the suspension, the authenticated registers shall be received from the licensing authority.

#### **Processing a request**

If the notification has been submitted in full to the competent authority for confirmation of changes or the applicant has complied with the authority's request for correction and the notification complies with the legal requirements, the authority shall issue a decision. The electronically authenticated decision shall be issued and sent by the Police to the requesting customer.
