Procedural order

Submitting an application

Depending on the location of the activity, the licence withdrawal application shall be submitted to the relevant county Police headquarters. If this is in Budapest, it will be to the Metropolitan Police Headquarters.

Costs and expenses of the procedure

The applicant shall present the original of the attached document at the request of the authority.

Processing the application

The authority dealing with the case will examine the provisions of the notification and if, on the basis of the latter, it determines that clarification of the factual situation is necessary, they will inform the client and summon them to a hearing, The electronically authenticated notice of summons will be issued and sent by the Police to the client making the notification. No personal appearance is required to receive the document.
