#### Procedural order

##### Submitting an application

The notification shall be submitted by the person eligible to hunt to the police headquarters whose jurisdiction covers the location of the activity (group hunting); if in Budapest, this will be to the Metropolitan Police Headquarters.

##### Costs and expenses of the procedure

The procedure is free of charge.

No attachment to the application is required.

## **Processing an application**

By submitting an application on the schedule of group hunting and on a change in the schedule, the client has fulfilled his statutory obligation. During the planned inspections of the police authority, it shall act in the light of the notification.
