#### **Submitting an application**

An application for revocation of a public security license shall be submitted to the public authority issuing the public security authorization, the head of the county (metropolitan) police headquarter, by the head of the body employing the natural person. The applicant is an economic entity licensed for the use of nuclear energy in all cases, irrespective of whether it applies for the revocation of a public security license for a worker who is employed by his own employer or his subcontractor for another contractual partner.

For revocation, the applicant shall provide the full official authority number of the public security license to be withdrawn and the exact date of the issue. If the registration number differs from the form indicated in section 1 of the form, it shall be entered in box 2 of the form in the format indicated on the public security clearance. If the business entity organization submitting the application cannot provide data on the form and date of the public security license because

of the loss or destruction of the public security authorization, it is obliged to make a declaration referring to it!

**No attachments to the application are to be added.**

**Processing the application**

If, during the processing of the application, both the applicant and the public security authorization to be withdrawn, and also the employee concerned can be identified, the authority will revoke the public security authorization and inform the applicant in writing by means of a decision in electronic form.
