Procedural order

Submitting an application

The application of a natural person shall be submitted to the police headquarters competent for the place of residence, in the case of possession of a firearm for self-defense purposes, to the county police headquarters competent in his place of residence, in Budapest to the Budapest Police Headquarters.

Notification of the organization authorized to hold firearms for sport shooting, shooting education, target shooting, work, film production, theatrical weapon to operate shooting range, to repair weapon, to use of a museum weapon for sport shooting, shall be submitted to the police headquarters of the place where he is employed, in Budapest to the Budapest Police Headquarters.

Notification of the organization authorized to hold firearms of category "A" for personal and property protection, silencers and authorized to manufacture, distribute weapons, ammunition and ammunition elements shall be submitted to the County Police Headquarters of the place where the organization operates, in Budapest to the Budapest Police Headquarters.

Costs and expenses of the procedure

The procedure is free of charge

The applicant shall present the original of the attached document at the request of the authority.

Processing the application

The authority dealing with the case will examine the provisions of the notification and if, on the basis of the latter, it determines that clarification of the factual situation is necessary, they will inform the client and summon them to a hearing, The electronically authenticated notice of summons will be issued and sent by the Police to the client making the notification. No personal appearance is required to receive the document.
