Procedure

Submitting the application

The application for requesting a licence to operate a storage area for firearms, ammunition and ammunition components or change the storage area must be submitted to the relevant local police department, county (municipal) police department of the place of activity of the organisation; in Budapest, the Budapest Police Headquarters.

Costs and expenses of the procedure

- HUF 15,000 for up to 25 firearms and/or ammunition up to 5000 pcs,
- HUF 35,000 for between 26–50 firearms and/or 10,000 pcs. of ammunition
- HUF 45,000 for 50+ firearms and/or 10,000 pcs. of ammunition,
- ammunition components storage area: HUF 35,000,
- HUF 3,000 for change the storage area (basic fee)

Payable to the appropriation allocation bank account held by the relevant local police department or relevant county police department in the first instance; in Budapest, the Budapest Police Headquarters.

The administrative Service Fee can be paid by bank transfer or via the Electronic Payment and Settlement System (EFER) via online bank card payment (VPOS).

In the case bank transfer, the information field must contain the purpose of the payment e.g. „, an application for requesting a licence to operate a storage area for ammunition and ammunition components” and the registration number returned after the automatic registration, which is a case number consisting of the following positions:

Attachments to be added to the application submitted in pdf files

- in the case of application for a licence to operate a new storage area a sketch and security description of the firearms and ammunition storage facility, if available.

The applicant, if called upon by the authority, must produce the original copy of the attached document.

Processing the application

If during processing the application it is established that the applicant has submitted the complete application to the authority having appropriate jurisdiction, and during the inspection of the storage area it is established that the conditions of storage as required by the law have been met, the Police shall send the applicant the electronically certified copy of the decision. No personal appearance is required when taking receipt of the permit.
