Procedural order

Muzzle-loading weapons for hunting use must only be licensed to natural persons.

Submitting an application

An application for the use of a muzzle-loading weapon for hunting purposes shall be submitted to the police headquarters whose jurisdiction covers the domicile of the applicant; if in Budapest, this will be to the Metropolitan Police Headquarters.

Costs and expenses of the procedure

HUF 6,000 administrative service fee, which is paid to the county police headquarters which is initially responsible for the case. If in Budapest, this will be the appropriation allocation fund account of the Budapest Police Headquarters. The payment shall be made no later than the day following the date of receipt of the registration number of the determining authority. The reference section shall indicate the reason for the deposit as a "muzzle-loading weapon request" and the number of the case. Registration number: the "RZSEIR" registration number indicated on the notification sent by the document management system of the Police to the applicant's Customer's Gateway storage space).

PDF extension files to be attached to the application

- Exam certificate confirming the existence of theoretical and proficiency requirements necessary for the lawful use of the muzzle-loading weapon;
- A medical certificate issued in accordance with aptitudes of group II. by the applicant's general practitioner is required for the use of a muzzle-loading weapon.
- (The attachment of a medical certificate is not required if the applicant has a valid firearms licence or, at the time of filing the application, he has submitted an application for holding a firearm and, on the basis of the application, he is found adequately healthy for holding a firearm);
- a valid hunting permit.

The applicant is obliged to produce the originals of the attached documents if required so by the authority.

Processing an application

If the person submitting the application has submitted the application to the competent and relevant authority or has fulfilled the authority's request for correction, the storage site for the ammunition item conforms to the requirements of the Gov.D. on the basis of the check carried out and there is no exclusionary reason established by the Ftv. for the applicant, the Authority shall authorize, in the form of a simplified decision the use of the muzzle-loading weapon for hunting purposes. The electronically verified licensing decision shall be issued and sent by the Police to the applicant. During the procedure, no personal appearance is required to receive the licence.
