#### Procedure

### **Submitting the application**

Regarding a licence for possessing firearms, the application must be sent to the relevant police department of the place of activity of the association; in Budapest, the Budapest Police Headquarters.

## Costs and expenses of the procedure

- licensing the possession of firearms for associations: HUF 3,000 for each weapon
- licencing to possess prop firearms shall be HUF 13,000, additionally a fee of HUF 2,000 shall be payable for each firearm
- in case of associations, the necessary permits to employ personnel possessing firearms and ammunition, as well as the licences for employees, respectively: HUF 2,000 for each person;
- permits for storage of firearms, ammunition, ammunition component storage:
  HUF 15,000 for up to 25 firearms and/or up to 5000 pcs.of ammunition;
  HUF 35,000 for between 26 to 50 firearms and/or 10,000 pcs. of ammunition;
  HUF 45,000 for 50+ firearms and/or 10,000 pcs. of ammunition;
  ammunition component storage: HUF 35,000.

The exchange or replacement of licence (per card document) is HUF 4,000.

Payable (in advance or ex-prior) to the appropriation allocation bank account held by the relevant county police headquarters in charge of the police department initially involved; in Budapest, the Budapest Police Headquarters.

The administrative Service Fee can be paid by bank transfer or via the Electronic Payment and Settlement System (EFER) via online bank card payment (VPOS).

In the case bank transfer, the information field must contain the purpose of the payment e.g. " Licence application for associations for possession a firearm - for work, education, sports and film production (publishing, replacement, replacement)" and the registration number returned after the automatic registration, which is a case number consisting of the following positions:

## Attachments to be added to the application submitted in pdf files

- a certificate evidencing the applicant's theoretical knowledge and practical skills required by rule of law to possess firearms;
- a certificate of the preliminary medical assessment (issued by the relevant occupational health authority);
- a sketch and security description of the firearms storage facility;

In a case of firearms for work:

- justification or document stating that the possession of the firearm is necessary for the applicant's activities or responsibilities;

In a case of firearms for shooting sport:

- a federal membership certificate issued by the National Sports Federation (for applicants of sport associations)
- a shooting range operating license for the type and caliber of the firearm to hold (for organization applicants)

In a case of firearms for education:

- a shooting range operating license for the type and caliber of the firearm to hold (for organization applicants)

In a case of pop firearms:

- a permission of an employee or member to engage in arms manufacturing activities.

# **Processing the application**

If during processing the application it is established that the entitled applicant has submitted the complete application to the authority having appropriate jurisdiction, and the conditions of granting the licence as required by the law have been met, or the applicant has complied with the request for correction or amendment, the authority shall make a decision of granting a licence to possess firearms (licence). The licence and the official card evidencing the licence (document/card) can be collected by the licence holder in person via their authorised trade representative from the licensing police authority during business hours.

In the event of exchange or replacement of the license, the new license may also be received personally by the licensee through its commercial agent. At the same time as the new license is received, the license to be replaced must be submitted to the authority.
