#### **Submitting an application**

In the case of an organization, a document attesting the participation in shooting trainings of employees entitled to use a firearm at regular intervals, but at least four times a year, shall be

forwarded by the head of the organization to the to the Police Headquarters whose jurisdiction covers the location where the activity is carried out; in possession of a firearm for personal and property protection or a firearm or silencer for work in category A to the county Police headquarters which has jurisdiction for that location; in Budapest, to the Budapest Police Headquarters

### Costs and expenses of the procedure

The procedure is free of charge.

No attachment to the application is required.

## Processing the application

The provisions of the certification shall be noted and recorded by the authority, which shall not make a separate acknowledgement to the client. By submitting a certificate of shooting training, the customer fulfilled his statutory obligation for the subject year.
