#### Procedural order

##### Submitting an application

The licence withdrawal application shall be submitted to the city (district) police headquarters whose jurisdiction covers the activity carried out. If in Budapest, this will be the Metropolitan Police Headquarters.

Application for the withdrawal of a license to carry a firearm, shooting education, target shooting, firearm for work, film production, to operate a shooting range, repair a weapon, use a museum weapon for sport shooting, or hold a theatrical weapon should be submitted to the

Police Headquarters of the place where the organization operates, in Budapest to the Budapest Police Headquarters.

Application for withdrawal of license to hold, distribution and manufacturing a firearm for personal and property protection, firearm and silencer of category “A”, firearm and silencer category “A” for film production, shall be submitted County Police Headquarters of the place where the organisation operates, in Budapest to the Budapest Police Headquarters.

### **Costs and expenses of the procedure**

The procedure is free of charge.

No attachment to the application is required.

### **Processing an application**

The provisions of the application shall be acknowledged by the authority which will make a decision accordingly. The electronically authenticated decision shall be issued and sent by the Police to the applicant. No personal appearance is required in order to receive the decision.
