## **Procedural order**

### **Submitting an application**

The licence application for import, export or transit shall be submitted to the police headquarters relevant to the domicile in the case of a natural person; if in Budapest, it will be to the Budapest Police Headquarters. In the case of a firearm licence holder for the protection of persons and property; a small firearms licence holder with the sole purpose of self-defence, the application should be submitted to the county Police headquarters; if in Budapest, this will be to the Metropolitan Police Headquarters. In the case of transit of firearms and ammunition, the licence application shall be submitted to the county (metropolitan) police headquarters responsible for border crossing. The licence application for the import and export of theatrical weapons shall be submitted to the relevant police headquarters at the border crossing entry point of Hungary.

### **Costs and expenses of the procedure**

4,500 HUF per firearm, or 2,000 HUF for ammunition only.

8,000 HUF for one theatrical weapon, and 2,000 HUF for each additional weapon, which administrative service fee must be paid to the appropriation utilization framework account of the Budapest Police Headquarters in Budapest or to the county police headquarters acting in the first instance, with advance or post-payment.

The administrative service fee can be paid by bank transfer or online credit card payment (VPOS) using the Electronic Payment and Settlement System (EFER). In the case of a transfer, the reason for the payment must be indicated in the notification box, for example: "export of a firearm" and the registration number of the case. The registration number consists of the following positions: X X X X X - X X X / X X X / X X X X. F. (eg: 29000-821 / 111/2019. F.)

No attachment to the application is required.

### **Processing an application**

If during the processing of the application it is established that the authorized client has submitted the application in full to the competent authority, and the legal conditions for authorization are met or the request for rectification has been complied with, the authority makes a decision in the form and content specified in the Government Decree, which the licensee or, in the case of an organization, the commercial agent may pick up in person from the licensing police authority at the time of reception.
