



## HATÁRRENDÉSZETI KIRENDELTSÉG GYULA

### **EXTRACT FROM THE FUNCTIONAL REGULATIONS OF THE COMMON CROSS-BORDER TRAFFIC AND BORDER CROSSING POINT AT GYULA**

1. The functional regulation of the border crossing point includes all the rules and regulations that must be kept by the executive staff on duty involved in the checking, the people who are present at the border crossing point without passing it, and the passengers at the checkpoint and their vehicles and goods. The functional regulation regulates the cross-border traffic's safe and undisturbed check, ensures the order of the state border at the frontier zone, and also prevents, clears up and interrupts dangerous activities.
2. The passenger who arrives at the border crossing point is obliged to present the travelling documents and other documents concerning the passenger and vehicle traffic, and documents concerning the transported goods to the executive staff on duty for checking. The objects which are the passengers' property may also be checked. The passengers are allowed to leave the area of the border crossing point only after the control and with the permission of the executive staff.
3. The passengers and the vehicles are allowed to stay on the area of the border crossing point only for the period of the checking, for derulation of other procedures and for authorized legal activities.
4. The checking of the international passenger and car traffic and the transporting devices happens with one stop, in the order of arrival at the checking point with the exception of those who are legally entitled.
5. The passengers and vehicles arriving at the border crossing point are guided by the traffic signs indicating the lanes and the road markings.
6. The use of the border crossing point at Gyula- Vársand is expanded to international passenger and goods traffic. The opening hours of the border crossing point are 0-24.
7. The apprehended persons temporarily can be stowed at assigned place of the border-crossing point. This persons are guarded by the authority, which initiate the measure.
8. The persons without the intention of passing the border are allowed to do their activities the the defined place and in the possession of the required permissions. During their

activity they cannot disturb and hinder the continuity and security of the execution of the checking.

9. Vehicles transporting international Carriage of Dangerous Goods by Road (ADR) are checked and parked at separately assigned parking area. Insofar as the parking place is totally filled up, the hungarian officer on duty assign the place for parking.
10. The passing of the border of the living animals transports happens using the operative law concerning the transporting rules.
11. Activity which endangers the security of the checking at the border checking point is forbidden.
12. The International Highway Code is used in traffic and parking on the area of the border crossing point. The passengers and the vehicles are not allowed to stay gratuitously on the area of the border crossing point.
13. The Functional Regulation of the Border Crossing Point must be interpreted and put in practice collectively with the Agreement between the Republic of Hungary and Romania concerning the railway and road traffic, signed in Bucharest on 27 April 2004; the Schengen codex concerning the border passing and the report signed on 04 January 2007 between the National Command of the Border Guard of the Republic of Hungary and the General Inspectorate of the Romanian Border Guard.
