

EXTRACT FROM THE FUNCTIONAL REGULATIONS OF THE RAILWAY-BORDER CROSSING POINT AT KÖTEGYÁN-SALONTA

- 1. The functional regulation of the border crossing point includes all the rules and reglementations that must be kept by the executive stuff on duty involved in the checking, the people who are present at the border crossing point without passing it, and the passengers at the checkpoint and their vehicles and goods. The functional regulation regulates the cross-bord traffic's safe and undisturbed check, ensures the order of the state border at the frontier zone, and also prevents, clears up and interrupts dangerous activities.
- 2. According to §205 section (1) point b) of Act II. of 2012. anyone who breaches the restraining or restrictive orders connected to the order of the state border, border surveillance or border check, commits administrative offence.
- 3. According to §64 Section (1) of 30/2011. MI Regulation on the Regulation of Police Duties the police officer carrying out border check shall ask the person intending to cross the border to provide their travel document, and other documents required for checking passenger- and vehicle traffic or items that may be in the possession of the person intending to cross the border.
- 4. Operator shall continuously guarantee the conditions of undisturbed and civilised border check of passenger traffic and of goods.
- 5. The executive stuff of Kötegyán Border Policing Office perform the checking of the international passengers and vehicles at Kötegyán Railway Station during the scheduled downtime of the train.
- 6. The checking of the passenger trains happen at the railway station during the downtime of the train. The checking of the train has to be started from the front of the train. The authority border police check has to be the first, other check is not allowed to overtake it! The executive stuff perform the check of the passangers one at a time.
- 7. The service stuff and conductors of the international trains cannot work before checking of the border police. Activity which disturbing or traversing the border checking is not allowed.

- 8. The person travelling on a train shall not get off until the whole train has been subject to border check. Passengers are allowed to leave the train only after having been checked by the police.
- 9. Passengers shall get on the exiting train before the border check while the train is waiting. The border crossing train can be left only with the permission of the police officers on duty. Until departure the officers assist passengers getting on the train.
- 10. The police according the laws check the passenger traffic at checkpoints, during scheduled downtime of the international train.
- 11. Claim of visa is not possible at the border crossing point.
- 12. The minimum check of the passenger takes place on the train, the second line check of passenger happens in the building of the Kötegyán Border Policing Office.
- 13. The passenger is given a written informative about the second line check. The result of the second line check can be that the passenger can cross the border, or not, or have to initiate further procedure.
- 14. In case of ban on entry the passenger normally has to leave the country with the next exciting train. If the next train comes on the next day, the officer give effect to transport of the passenger and his baggage(s) to the Méhkerék Border Crossing Point, where the exciting can be performed.
- 15. The state border may be crossed at Kötegyán railway border crossing point by international train service operated for the transportation of international passenger traffic.
- 16. Clearance for border crossing is given if the passenger possesses original, valid travel documents according to regulations in force-, has the necessary supporting documents, and is not subject to restraining orders.
- 17. Participants of border traffic must report at the authority (Police) carrying out border check for border crossing clearance.
- 18. In order to secure the measures taken in case of ban on entry, the police may designate a place to stay until the next train departure. Kötegyán Border Policing Office designates the WAITING ROOM OF KÖTEGYÁN TRAIN STATION as a place to stay until the departure of the returning train according to §42 section (1) point b) of Act II of 2007.
