## **EXTRACT**

### **INTERNAL ORDER CONCERNING BORDER CHECKS AND TRAFFIC FLOW MANAGEMENT AT LÉTAVÉRTES-SACUENI BORDER CROSSING POINT**

The regime of Border Crossing Point includes regulations which shall be followed by involved authorities and border crossers in order to carry out fast and secured border control procedures.

#### **This internal order contains the following instructions regarding the border crossers:**

##### **Area of Border Crossing Point:**

The territory of Border Crossing Point is surrounded by fence and particularly marked with boards / signs.

##### **The method of border checks:**

Border checks are jointly conducted by the Hungarian Police and Romanian Border Police staff members at the marked locations. In case of cars and motorcycles the one-stop control is fulfilled at the middle line of the booths. Lorries shall be stopped by the indicated line of the exit control booth.

#### **Sequence of border checks concerning passenger flow enter to / exit from Hungary:**

Border checks are implemented on the territory of Hungary according to the traffic signs and information boards. There are two available traffic lanes, one for entry and one for exit direction. While border check is being performed, the officials start the procedure responsible for controlling exit conditions. At the same time visual check of the vehicle is completed by the officials responsible for entry. When the check of exit conditions is finished the travel documents are handed over to the officials in charge of controlling entry conditions. At last the entry conditions are being checked according to the national legal requirements.

#### **Obligations concerning passenger flow:**

Passengers and vehicles are obliged to follow the signposts and information boards regarding traffic flow management at the Border Crossing Point. Activities may hinder the safe completion of border checks are not allowed.

Entering to the area of the Border Crossing Point with no intention of border crossing may be provided to certain categories of persons according to national provisions.

Hungarian Police is the responsible authority in order to keep this Order's regulations including rules of entry and stay at the area of Border Crossing Point.

Traffic laws at the Border Crossing Point are applied according to the Hungarian Highway Code as stipulated in the No. 1/1975 (05.II.) MoT-MoI joint decree.

#### **Legal consequences in case of violations concerning this Order:**

The Order has been established by the Hungarian Police and it is considered as a part of the border regime. Each above-mentioned regulation in conjunction with the traffic rules are obligatory for all the participants of the border control procedures. According to the Police Law No. XXXIV. at 1994 § 1. section (2) point 11. violation of this Order or traffic related offence may result written warning, fine or infringement procedure considering the severity of the violation.
