Tiszabecs Border Crossing Point rules for passengers and drivers!

The Border Crossing point regulates these laws and rules, and determines these laws that are a mandatory! These are the mandates that the border police officers and passengers and drivers equally needs to follow in the process of border crossing for the efficient and fast passing through.

**The Border Crossing point of Tiszabecs Rules for the people that wants to cross through are these:**

**The Border Crossing Point Property:** The Border Crossing point is made of a closed system, The 491 th. numbered Main Road that follows the path to the Border Crossing Point. There is a sign before the border crossing point named: „Tiszabecs határátkelőhely” from this sign, to the other end, is the property of the Tiszabecs Border Crossing point.

**The Border Crossing Inspection:** The Inspection is made by the sequence of the people that was there before, between the lanes that are categorised by the type of passengers, **that are qualified by:**

- In-, or Outwards I. - II. - IV. lanes between all types of *people that wants to cross through (ALL PASSEPORTS)*,
- In-, or Outwards III. lanes that are for the EGT and EU States citizens, and the citizens with the rightful law of free movement can cross this lane. **(EU, EEA, CH)**

The *people* with vehicles can drive into the lanes with **Piktograms** /EU, EGT citizens can use the III.-rd lane, and every other people can use the **First and Second Lane and the Fourth Lane: I – II - IV** / The Lanes that are in the property of the Border Crossing Point, BEFORE driving into the right lane in the within the rules of Hungarian Traffic you can only, and ONLY change your lane if you were instructed by a Police Officer or if you have a permit to do so. People with Vehicles are **must stop** at the inspection point, according to the police officer instructions. The Pedestrians and cyclists must follow **LANE 1** that are builded for them and they can only transfer through this lane.

**The Passengers and Drivers Inspection Sequence are these:**

a) **if inward traffic (Into Hungary) :**

- Border Crossing Inspection with the colleagues of the NAV Customs, but beforehand the Nav Customs inspection can not be done.

b) **If Outward traffic ( Outward Hungary) :**

- Police Border Inspection and after that -  
- Nav Customs Inspection.

**The MANDATORIES that must be followed by the people that want to cross:** The pedestrians, drivers and every other type of people that want to cross are must show their documents to the police officer working in the inspection area, and the documents that the police

officer required for. You must cooperate with the police officer, while and during the transfer process.

The Vehicle Inspection and Cargo Inspection, the driver, or if they are absent then the passenger that is driving the vehicle, if the Police Officer or the Customs Officer demands that the cargo or the boot or the hood to be opened, including personal belongings you must cooperate and open them, get them out of the vehicle or into the vehicle.

---

***While you are being checked, the car engine must be stopped.*** The police officer who is doing the checking process and the NAV college orders are absolute and you must cooperate.

While your passport is being checked, at the same time the NAV colleges are doing the vehicle and personal belongings inspection. Before the vehicle and passport inspection you **MUST NOT** leave the vehicle and its area, except you can only do so to a police officer order. If you must need to leave the vehicle, before that you must inform a police officer about it.

If you are with a vehicle then the passport inspection and the NAV control will happen at the same place, and you must move the vehicle to the area that has been decided by the police officer. you can only leave this area and the area of the border crossing point if the NAV customs officer has given you permission for it or ordered it.

**After the inspection, the passengers and the driver must leave the area of the border crossing point.** Waiting, Stopping, and by these doing you mustn't annoy or interrupt people by foot and by vehicles.

While you are in the area of the border crossing point, you must obey the law of KRESZ. In the area of the border crossing point the maximum speed limit is 5 km/ h!

In the area of border crossing point, in regard of non-smoking defence the law has been made that you can **ONLY smoke** in your vehicle. **Littering** and throwing away other harmful materials, or letting it/they behind is **FORBIDDEN**. If you make any harm in the buildings, or any technical equipment, you are responsible for the harm that you caused and the repair cost is your responsibility.

#### **The rules and laws for the passengers:**

- Littering** in the area of the border crossing point is **FORBIDDEN**.
- It is **Forbidden to get out of the vehicle** in use to cross the border without permission or a police officer order.
- The pedestrians and cyclists must use the road that are made for them in the process of crossing the ukrainian (Vilok) border and hungarian (Tiszabecs) border.
- It is **FORBIDDEN** to use your phone for: **Photos, Videos**, and every other device to capture anything in the area of the border crossing point.
- It is forbidden to leave the area of the border crossing point without permission from the border crossing officers.
- It is FORBIDDEN to smoke in the area of the border crossing point.**
- From the point of the start of the border crossing point to the end of it, it is **FORBIDDEN** Parking and Waiting, you must follow a continuous progress of crossing.
- It is **FORBIDDEN** to park your vehicle or wait in it, **THIS** does not include waiting for administration, or by order.

#### **4. The price of violating these laws and forbidities:**

In the law of the border crossing point, **THOSE who violate these laws and forbidities the 2012. 2nd. law says that the police officers can use sanctions, if a police officer** detects, that you have violated one of these laws or forbidities he must act as he must to. He must stop or interrupt the process of violation.
